Needed for initial application:

- \$120.00 fee** For each circus or menagerie exhibited within the city limits.
- \$12.00 fee** For each additional separate exhibition, show or performance under same tent where an additional admission is charged.
- \$7.00 fee** For each additional performance beyond that contemplated above.

- Copy of business liability insurance in the amount of \$500,000 per incident.**
- Completion of Application for Business License**
- Completion of Affidavit of Lawful Presence (Sole proprietor or individual only)**

- Sales tax deposit.** Deposit is determined by estimated sales of concessions and merchandise-- minimum of \$45.00 for \$1300.00 of sales.

6.04.180 Circus or menagerie.

(a) For each circus or menagerie, or circus and menagerie combined, exhibited within the City limits, the fee shall be set in writing annually by the City Manager.

(b) For each additional separate exhibition, show or performance, under the same tent as that for which a license under Subsection (a) applies, where an additional admission is charged, there shall be an additional fee which shall be in an amount set annually by the City Manager in writing.

(c) For each additional performance beyond that contemplated by Subsection (a), there shall be an additional fee which shall be in an amount set annually by the City Manager in writing. (Ord. 28, 2007 §1; Ord. 26, 1993 §1(part); prior code §14-22(10))

<p>ADVISEMENT REGARDING USE OF COLORADO DEPARTMENT OF REVENUE EMERGENCY RULES FOR TEMPORARY ADDITIONAL IDENTIFICATION DOCUMENTS OR PROCEDURES</p>

The Colorado Department of Revenue requires the following advisement if the Applicant chooses to use one of the additional forms of identification authorized by its Executive Director pursuant to § 24-76.5-103(5)(a), C.R.S.:

1. Under current Colorado law, in order to receive benefits beyond July 1, 2007, Applicant must produce one of the following forms of identification: a valid Colorado driver's license or a Colorado identification card issued pursuant to Article 2 of Title 42, C.R.S.; a United States military card or a military dependent's identification card; a United States Coast Guard merchant mariner card; or a Native American tribal document.
2. As soon as possible, Applicant should begin working diligently to secure the appropriate identification document; and
3. A determination of eligibility for benefits based on an Alternative Identification or the Electronic Identification Indicator in no way constitutes a representation that Applicant has provided sufficient information or documentation to support the issuance of one of the forms of identification set forth in § 24-7605-103(4)(a) C.R.S.
