Many household chemicals pose serious health risk if not properly handled, stored and disposed of. It has never been easier to remove these hazards from your home.

Household Hazardous Waste Types

Residents of Greeley, Colorado may use the Weld County Household Hazardous Waste Collection Center to dispose of household hazardous chemicals. Greeley residents should seriously consider using the Center to dispose of these chemicals because they pose a treat to sanitation workers and anyone who comes in contact with them. These chemicals may also threaten ground water and the environment at the landfill.

- Antifreeze
- Car / Motorcycle Batteries
- Car Cleaners and Waxes
- Degreasers
- Deodorizes
- Drain Cleaners
- Expired Medicines
- Flea Powder
- Insecticides
- Lacquers
- Moth Balls
- Paints
- Paint Thinner / Remover
- Petroleum Products
- Photography Chemicals
- Radiator Flushes
- Rodent Poison
- Rug Cleaners
- Rust Removers
- Silver Cleaners
- Spot Removers
- Toilet Bowl Cleaners
- Used Oil / Filters
- Wood Preservatives

Some wastes cannot be accepted at the Weld County Household Hazardous Waste Center, including:

- Radioactive Materials (e.g., smoke detectors)
- Asbestos
- Shock-sensitive Materials (e.g., crystallized chemicals)
- Water Reactive Materials
- Biological Hazards or Infectious Agents (e.g., syringes, needles, bandages, etc)
- Construction Materials
- Explosive Materials
- Large Compressed Gas Cylinders or Tanks
