

City of Greeley 2011 Mandatory Watering Schedule



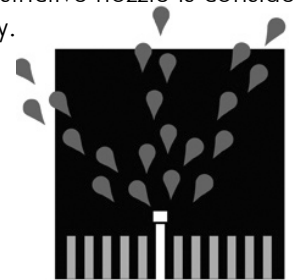
Single family residences & duplexes with **even** numbered addresses ending in:
0, 2, 4, 6, 8

Single family residences & duplexes with **odd** numbered addresses ending in:
1, 3, 5, 7, 9

All others: home owner association common areas, multi-family residences, apartments, businesses, government, non-profit, churches, commercial, industries, and institutions.

- No lawn watering between 12:00 p.m. (Noon) and 5:00 p.m.
- New lawn variances are available with proper soil amendment (4 cubic yards per 1,000 square feet of lawn). To properly water the lawn and comply with water restrictions a variance is required. Bring receipts for new sod or seed, compost installation, and proof of rototilling (photos, rental receipt or lawn service invoice) to the Water Department to apply.
- Trees, shrubs, flower and vegetable gardens may be watered at any time by hand, drip irrigation, low volume, bubblers or by weeping-type soaker hoses. Using a watering can or someone holding a hose with a restrictive nozzle is considered watering by hand. Water trees and shrubs during prolonged dry periods to keep trees healthy.
- Hosing paved surfaces, including decks, driveways, patios, sidewalks, and garages is not allowed. Occasional hosing of vinyl siding, roof gutters, windows, and surfaces in preparation of painting or staining is allowed within reason.
- Home car washing is allowed with a restrictive nozzle hose and bucket, and minimal runoff.
- Any person who violates the restrictions during a calendar year will be fined \$100 for the first offense, \$250 for the second, \$500 for the third, and for the fourth and subsequent violations \$500 and the cost of installing a flow restrictor to limit outdoor water use. Violations on non-residential property receives fines that are double to those described above.
