How to Apply

1. Purchase and install a washer according to program rules.
2. Return a completed application form and itemized original sales receipt.
3. Provide proof of US citizenship or legal status in the United States. Complete the Affidavit of Lawful Presence section of the application and provide identification to prove legal residency or a lawful presence in the United States.

A Colorado driver's license is the preferred form of ID. We also accept: U.S. military card or dependent's identification card, U.S. Coast Guard Merchant Mariner card, Native American Tribal document, Unexpired Resident Alien card, Permanent Resident card, Temporary Resident card or Employment Authorization card. Please inquire about other forms of ID, including out of state driver's licenses.

Applications are accepted in person and by mail. Greeley Water and Sewer staff will verify the identification of in-person applicants. Those who file by mail will need the Affidavit of Lawful Presence section notarized and a copy of his or her ID.

Program Rules

- The product must be purchased between Jan. 1, 2012 and Dec. 31, 2012. Rebate applications must be submitted within 90 days of purchase. All products purchased between Oct. 21, 2012 and Dec. 31, 2012 must be submitted before Jan. 14, 2013. The rebate program is subject to available funds.
- The purchased washer must be for use at an address that receives a City of Greeley water bill. Residents of other cities and/or customers of other water providers are not eligible. A Greeley water account number is required.
- One washer rebate per address or customer.
- The original sales receipt must be attached to the application and include the date of purchase, price, brand name, model number and serial number. Keep a copy of the receipt for your records or apply in person to keep your original.
- The city reserves the right to inspect the installation of any appliance for which a rebate is provided.
- Rebates can be filed by property owners or renters. Contractors or others working with a property they do not own cannot apply for a rebate. The homeowner is responsible for installation.
- To be eligible for a rebate, the washer model purchased appear on our qualifying list. The list of qualifying washers are available at www.cee1.org. The models listed were chosen for their efficient use of water and energy. The purpose of the rebate is to help make water saving products more affordable and help you choose a water efficient product.
