- New lawn variances are available with proper soil amendment (4 cubic yards per 1,000 square feet of lawn). To properly 0 water the lawn and comply with water restrictions a variance is required. Bring receipts for new sod or seed, compost installation, and proof of rototilling (photos, rental receipt or lawn service invoice) to the Water Department to apply.
- Trees, shrubs, flower and vegetable gardens may be watered at any time by, drip irrigation, low volume, bubblers, sprinkler, 0 restrictive hose nozzle, watering can, by weeping-type soaker hoses or by a hose-end sprinkler. Water trees and shrubs during prolonged dry periods to keep trees healthy.
- Hosing paved surfaces, including decks, driveways, patios, sidewalks, vinyl siding, roof gutters, windows, and garages is 0 allowed with minimal runoff. Excessive water flow into the gutters and leaving your property is considered waste and could result in a violation.
- Home car washing is allowed with a restrictive nozzle hose and bucket, and minimal runoff. 0
- Any person who violates the restrictions during a calendar year will be fined \$100 for the first offense, \$250 for the second, 0 \$500 for the third, and for the fourth and subsequent violations \$500 and the cost of installing a flow restrictor to limit outdoor water use. Violations on non-residential property receives fines that are double to those described above.
