Item 1:	<b>Q1: Is it the City's intent to keep the 30" pipe in place or upsize the pipe with this project?</b> A1: The City is hoping the 30" pipe is sufficient to attain project goals with upsized inlet infrastructure. If the hydraulic analysis shows this is not the case, the City still intends to move forward with constructing an alternative that improves existing conditions. As part of the alternatives analysis, a long-term CIP project alternative may be proposed that would be added to the City's long-term CIP plan.
Item 2:	<b>Q2: The Pre-proposal presentation states the RFP must be 18 pages, but the RFP lists a maximum of 15 pages. Which is correct?</b> A2: The RFP is correct. Please limit proposals to 15 pages.
Item 3:	<b>Q3: Can proposals include 11x17 pages, and how are those counted towards the page count?</b> A3: Pages shall be 8 $\frac{1}{2} \times 11$ inch except for up to four (4) pages of 11 x 17 inches. Eleven-point font or larger must be used for the proposal and appendices. Resumes included as an appendix are not considered part of the 15 pages.

Item 5:	RFP/BID Number was written incorrectly on the Power Point presentation. The correct BID Number is listed above under Project Information.
