Item 2	The excel bid schedule quantities are carried out to multiple decimal places and as a result may not match the extended pricing as shown on the rounded numbers in the project manual bid tab.
	Do you want the bids to reflect the units on the excel bid tab or the units in the project manual bid tab? Bid Item Quantities (not dollar amounts) should be rounded to the nearest whole number. I have attached an updated xls with whole numbers in the quantities column, if you want to attach it.
Item 3	The bid schedule shows item 29, Stamped Concrete (Add On) unit to be "CY". However the measurement and payment section of the project manual shows the unit to be "SY". SY is typical for stamped concrete. Please clarify. Stamped Concrete is in fact measured in SY (square yards). Please see revised Bid Tab.

Item 4	Bid Item 29,Stamped Concrete (Add On) bid schedule unit is CY, but project manual calls out SY. Typical is SY. Unit of measure for Bid Item 29 it SY. (Also corrected in revised Bid tab)
Item 5	What pay item should the two inlet removals be covered under? I suggest that they be included in Item 32, Remove 6" CMP. Change bid item 32: Remove 6" CMP (19th Ave & 25th St) description to – Remove 6" corrugated metal pipe 0-2 foot depth including 2 "bubbler" inlets at the ends of the CMP run.
Item 6	Section 00620 - Special Provisions, Item 4, Contract Time & Scheduling states "All streets will remain open to traffic". I request that street closures be allowed with PM's approval. Change wording to: Street closures will be allowed with COG Traffic Engineer and PM's approval.
