

2023 SCHEDULE OF HEARINGS AND APPLICATION DEADLINE DATES FOR LIQUOR LICENSES

Please send your new/transfer/change of class/change of location/permanent modification application by email at: cityclerk@greeleygov.com or dropping off at City Hall. You will be contacted to schedule an intake meeting by the staff member assigned to your application, but if you have questions, you may email us at: cityclerk@greeleygov.com

Maintenance of this docketing schedule is necessary to ensure timing of corrected documents, proper public notice and premise posting in accordance with State Liquor Code and Liquor Licensing Authority (LLA) Rules of Procedure.

For 2023, deadline dates are generally on the Monday of each month that is at least 30 days from the earliest LLA hearing date that an application could be scheduled, but we reserve the right to move deadline dates to an earlier week as needed.

LLA public hearings occur on the selected Fridays every month, begin at 3PM, and generally, are held over zoom..

Please note: deadline dates for filing will be changed as needed to: I) Tuesday to accommodate city holidays, or II) an earlier Monday so that new application hearings are at least 30 days from filing date.

Examples of liquor license applications without petitioning are renewal hearing, temporary modifications with comments or concerns, special event liquor permits with comments or concerns, and transfer applications where review criteria require a LLA transfer hearing with no permanent modifications planned.

Examples of liquor license applications with petitioning are new licenses, change of class or change of location applications, and permanent modifications with all of these applications requiring neighborhood boundary setting for petitioning during the LLA hearing the month prior to the LLA application hearing.
