#### I. Call to Order and Roll Call

Chair Thompson called the meeting to order at 4:00 p.m. Commissioners Gifford, DePetro, McLean, Brunswig and Podell were present. Commissioner Sattler was absent.

#### **II.** Approval of Minutes for the meeting held on July 6, 2020

Commissioner Brunswig noted one correction at the end of number four to change the spelling of Thomspon to Thompson. With that correction, Commissioner McLean moved to approve the amended minutes dated July 6, 2020. Commissioner Brunswig seconded the motion. The motion carried 5-0 (Commissioner Sattler was absent)

Survey Plan Grant Project

The City of Greeley obtained a grant from the State Historical Fund to hire a consultant to develop a plan for historic resource surveys in Greeley, east of 35<sup>th</sup> Avenue. The City hired Logan Simpson to complete the project, which includes a review of previously completed surveys, complete a reconnaissance/windshield survey of the area and provide recommendations for future surveys. The primary goal of the project is to get a clear picture of existing surveys with recommendations for areas for future surveys to guide historic preservation survey projects in the future.

Logan Simpson project team members, Jennifer Levstik and Langston Guettinger came to Greeley and met with Staff in October to discuss the project, get information on previously completed surveys, and to complete the reconnaissance survey field work. They have completed the field work and are gathering public input to start the draft of the survey plan.

At the Commission meeting on Monday, November 16, 2020, Logan Simpson, including Jennifer Levstik, Langston Guettinger, and Jennifer Gardner, will introduce themselves and the project, go over their project methodology, provide an overview of their fieldwork and preliminary findings, and take public input.
