PLANT INVESTMENT FEES FOR NON-POTABLE SERVICE SHALL BE BASED ON THE COST OF THE SYSTEM CONSTRUCTED TO PROVIDE NON-POTABLE SERVICE. THE PLANT INVESTMENT FEE WILL BE THE PRO RATA SHARE OF THE NON-POTABLE SYSTEM CONSTRUCTION, BASED ON IRRIGATED ACREAGE, AS DETERMINED BY AGREEMENT. IF THE NON-POTABLE SYSTEM HAS NOT YET BEEN CONSTRUCTED AND CONSTRUCTION COSTS ARE NOT KNOWN, THE PLANT INVESTMENT FEE IS SET AT \$11,400 PER ACRE OF IRRIGATED TURF.
