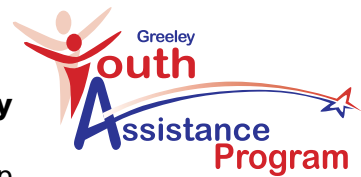


Youth Assistance Program

Applications are available at the Front Desk of the Greeley Recreation Center, The Family FunPlex, or The Rodarte Community Center. Contact 336.4206 or 350.9430 for further information.



The Youth Assistance Program is available for families that have a financial hardship and would still like to have the opportunity for their children to participate in City of Greeley Recreation Programs. The Greeley Culture, Parks, and Recreation Department raises money through a variety of sponsorships and donations for the Youth Assistance Program. As long as there are funds available, we will try to accommodate all requests.

Qualification Process and Information:

1. Participants must be Greeley residents and must provide a letter of qualification issued by School District 6 for the FREE or Reduced Rate Lunch Program. A copy of this letter must be provided for each child. For Greeley residents attending other school districts, applications will be looked at on a case-by-case basis.
2. Once qualification is confirmed, the child can utilize a \$50 scholarship toward registration costs for any class or program offered in the *Recreation Connection* brochure.
3. Once the scholarship is used up, youth (17 & under) who qualify for the FREE Lunch Program receive a 50% discount on **NON-CONTRACTED** classes and programs, and those who qualify for the Reduced Rate Lunch Program receive a 25% discount on **NON-CONTRACTED** classes and programs.
4. A database photo of each family member utilizing this program must be taken at the front desk of the Greeley Recreation Center or Family FunPlex. ID cards are not required.
5. The Youth Assistance Scholarship of \$50 will expire December 31st of the calendar year of approval. The reduced rate discount will expire 1 year from the date of approval.
6. The Youth Assistance Program cannot be used toward any membership or pass.
7. Participants and parents can enjoy a \$1 off daily fee discount at the following facilities:
 - Greeley Recreation Center • Family FunPlex • Ice Haus (\$1 off general admission only)

Programa de Asistencia para Jóvenes

Las solicitudes están disponibles en el área de servicio al cliente del Centro de Recreo de Greeley (Greeley Recreation Center), el FunPlex Familiar (Family FunPlex) y el Centro Comunitario Rodarte (Rodarte Community Center). Para información adicional llame al 336.4206 o 350.9430.

El programa de asistencia económica para jóvenes esta disponible para familias con dificultades económicas y quienes desean que sus hijos participen en los programas recreativos que la Ciudad de Greeley ofrece. El departamento de Cultura, Parques, y Recreo de la Ciudad de Greeley recauda dinero para el programa de asistencia económica por medio de donativos y patrocinadores. Siempre y cuando tengamos fondos disponibles, las solicitudes serán procesadas.

Proceso de cualificar e información general:

1. Es necesario que los participantes sean residentes de Greeley y deberán proveer una carta confirmando que cualifican en el programa de almuerzo gratis ó de costo reducido del distrito escolar 6. Tienen que proveer una copia de la carta expedida para cada niño. Aquellos residentes de Greeley quienes atienden otros distritos escolares, serán evaluados de forma individual según su caso lo amerite.
2. Una vez confirmado en el programa, el participante podrá utilizar la beca de \$50.00 para los costos de registración de cualquier clase ó programa ofrecido en la revista *Recreation Connection*.
3. Una vez la beca haya sido utilizada, los jóvenes (17 años y menos) que cualifican para el programa de almuerzo gratuito, recibirán un 50% de descuento en las clases y programas **no contratados**. Aquellos que cualifican para el programa de almuerzo de costo reducido recibirán un 25% de descuento en las clases y programas **no contratados**.
4. Cada miembro de familia utilizando este programa, deberá solicitar al personal del área de recepción del Centro de Recreo de la Ciudad de Greeley o del FunPlex Familiar, el que le tomen una fotografía digital para nuestra base de datos. Identificaciones con foto no son requeridas.
5. La beca de asistencia para jóvenes de \$50 expirara en Diciembre 31 del año en que fue aprobado. El descuento para aquellos con costo reducido expirara al año de haber sido aprobado.
6. El programa de asistencia para jóvenes no puede ser utilizado para membresías ó pases existentes.
7. Participantes y sus padres podrán disfrutar la reducción de \$1 de descuento al cargo diario en las siguientes facilidades de la Ciudad de Greeley:
 - Centro Recreativo de la Ciudad de Greeley • FunPlex Familiar • Pista de Patinaje en Hielo / Ice Haus\$1 de descuento del precio de admisión general solamente.
