Question #1	In regards to the 7" permanent patching. The specs are calling for the top 3" to be (SX)(PG 64-28) modified oil. We have done the City of Greeley KGM project for a number of years and the 7" full depth patching has always called for all (S)(PG 64-22). The ½" SX and PG 64-28 oil is more expensive.
Answer	(S)(PG 64-22) full depth patching will be allowed.
Question #2	Do you have any erosion control drawings for this project?
Answer	No erosion control drawings have been prepared. The contractor will be responsible for preparing and submitting a Storm Water Management Plan for this project and obtaining a CDPHE Construction Stormwater Discharge Permit as needed.

north bound land Phase 1 pipe alig and eliminate the costs for remobil	arifications are provided to modify responses provided in Addendum #1 and allow full closure of the e from 25th Street Road to 28th Street such that the contractor can mill the entire stretch of the grament. Closing the entire stretch of the north bound lane will eliminate the need to reopen sections e use of millings and temporary cold patch. The purpose of these modifications is to (1) reduce the lizing a milling machine, (2) allow the contractor to haul off the millings during the milling process, e the use and cost of cold patch material.

In Addendum #1, Question #8 asked if there are any restrictions as far as traffic control. The city's revised response is as follows:

The city will allow the north bound lane to be closed between 25th Street Road to 28th Street during Phase 1 work and Phase 2 Permanent Longitudinal Patching. The south bound lane shall remain open to provide one direction of travel. If an area within a segment will not allow for one lane of traffic, full closure will be permitted, but will be limited to day time only and reopened at night. All closures will require detours around the affected areas. The city will be responsible for notifying the public, residents, and emergency services of lane and road closures. However, the contactor will be required to allow full time access to the driveways along Reservoir Road. When work is being completed such that access is not permitted, the contractor shall coordinate directly with the property owner being affected to make arrangements such that their autos can be moved out of their driveways to avoid being stranded.

In Addendum #1, Question #16 asked if temporary asphalt patching is required at the end of each day? The city's revised response is as follows:

The use of cold patch is not required. This is based on full closure of the north bound lane between 25th Street Road to 28th Street for the duration of Phase 1 work and Phase 2 Permanent Longitudinal Patching. Road base or millings shall be used to bring the road up to grade where residents drive over the pipe trench to enter and exit their driveways. The contractor shall complete the permanent longitudinal asphalt patch within 10 calendar days after Phase 1 work is completed and the north bound lane reopened. If the contractor decides they want to reopen segments of the north bound lane before all Phase 1 work is completed and the permanent patch being placed, 2" of cold patch will be required where exposed to traffic and will be at the contractor's sole cost.

In Addendum #1, Question #15 asked if the contractor can mill the existing asphalt in place, providing we maintain the surface? The city's revised response is as follows:

Yes, the city will allow millings to be used as a temporary road base. However, the need for providing a temporary road base is not required as long as traffic is not allowed to drive on it.
