INSTRUCTIONS FOR USEFUL PUBLIC SERVICE

Useful Public Service for Noise Violations must be completed in the City limits

1. Select an agency from the list below, or select another non-profit organization of your choosing. (Work performed for a family member, a business, or an agency with which you have an affiliation does not qualify as useful public service.)
2. Contact the agency to make your arrangements to perform your useful public service hours.
3. Document your hours worked on the *Useful Public Service Work Log* available at the court, or you may ask the person(s) for whom you worked to provide you with a letter including the needed information, including:
 - The agency name and address
 - The type of work you performed
 - The printed name and signature of the person for whom you worked
 - This person’s telephone number
4. *Return the Useful Public Service Work Log to the Greeley Municipal Court at least 3 days before your scheduled court date and if all other obligations are completed, no further appearance in Court will be necessary, unless otherwise ordered by the Court. Completion can also be emailed to mccourt@greeleygov.com.*
5. Please be aware that the Court verifies all useful public service. It is a felony to provide fraudulent documents to a Public Servant.
6. **THE COURT WILL NOT ACCEPT USEFUL PUBLIC SERVICE COMPLETED ONLINE.**
