"Septage" is the liquid domestic wastewater and solid material pumped from a septic tank, cesspool, or other primary treatment source.

"Domestic Wastewater " is a combination of liquid wastes (sewage) which may include household chemicals, household wastes, human excreta, animal or vegetable matter in suspension or solution or other solids in suspension or solution which are discharged from a dwelling, building or other structure. Domestic Wastewater does not include commercial or industrial wastewater or grease removed from a restaurant grease trap.
