Commercial Rebate Rules:



- The product(s) must be purchased between January 1, 2022, and December 31, 2022.
- Rebate applications **MUST** be submitted within 90 days of purchase. All products purchased between October 14, 2022, and December 31, 2022, must be submitted before January 14, 2023.
- Only Greeley water customers in good standing (account with a zero balance) may apply.
- Product must be for use at address that receives a City of Greeley water bill. Commercial, industrial, multi-family, non-profit/governmental, institutional properties with a City of Greeley water account number may apply for rebates.
- The original sales receipt/or paid invoice must be attached to the application and include the date of purchase, price, brand name, model number, serial number and applicants name and address.
- Rebates should be filed by business owners or approved personnel. Contractors or others working with a property, they do not own, cannot apply for a rebate. The applicant is responsible for proper installation.
- The City reserves the right to inspect the installation of any appliance for which a rebate is provided.
- The application form contains information on the commercial product available for rebates, the dollar amounts, and specifications on the products. If a product does not fulfill the minimum standards, a rebate will not be issued.

How to Apply:

Contact the Greeley Water Conservation Office at 970-350-9874 to check if funding is available. This is especially important when initiating large scale projects or toward the end of the year. **To qualify for \$25 toilet recycling incentive you must take old toilets to the Recycle Center (see below) and receive a voucher. Voucher must accompany commercial rebate application.**

All non-ceramic parts must be removed.

- Purchase and install device(s) according to program rules.
- Mail or email completed form and receipt of purchase to the Water Conservation Office. Applications are not accepted in person until further notice.
- If business type is a sole proprietorship, you must also complete an affidavit of lawful presence form.

The city can no longer accept the toilets for recycling at the GROW recycle center in Greeley, please see these two places below where you can recycle your toilet in Fort Collins. **All non-porcelain parts must be removed to drop off the toilet and receive the voucher i.e. seat, plastic, tank parts and metal screws, etc.**
