TOILET REBATE INFORMATION AND PROGRAM RULES

Important: Conservation program only rebates .8 gpf flush toilets @ \$50.

High efficiency toilet rebate rules:

- Toilet(s) must be purchased between January 1, 2019, and December 31, 2019.
- Rebate applications MUST be submitted within 90 days of purchase. All toilets purchased between January 1, 2019, and December 31, 2019, must be submitted before January 15, 2020.
- Rebates are subject to available funds.
- Only Greeley water customers in good standing (account with a zero balance) may apply.
- If renting, you must have a letter signed by owner authorizing you to install a new toilet.
- The purchased toilet must be for use at an address that receives a City of Greeley water bill. Residents of other cities and/or customers of other water providers are not eligible. A Greeley water account number is required.
- Rebate is limited to two toilets per residence.
- New toilets must replace 1.6 gallon per flush toilets (gpf) or 1994 and older.
- Conservation program only rebates .8 gpf flush toilets @ \$50.
- The City reserves the right to inspect the installation of any appliance for which a rebate is provided. Rebates can be filed by the property owners or renters. Contractors or others working for a property they do not own cannot apply for the rebate. The homeowner is responsible for installation.

How to Apply:

- To qualify for the \$25 recycle incentive please take your old toilet to The Grow Center located at 1130 E. 8th St. (see map below) * **ALL NON CERAMIC PARTS MUST BE REMOVED.**
- Recycle voucher must be submitted with application to receive \$25 credit and only in conjunction with a toilet rebate.
- Bring completed form and receipt of purchase to the Water Conservation Office located at: 1001 11th Avenue, 2nd floor, Greeley, CO 80631. Applications are accepted in person or by mail.
- If you file by mail you will need to have the application notarized.
- Identification will also be required. A Colorado driver's license is the preferred form of ID. We will also accept U.S. military card or passport. Please inquire about other forms of ID. Including out-of-state driver's licenses.

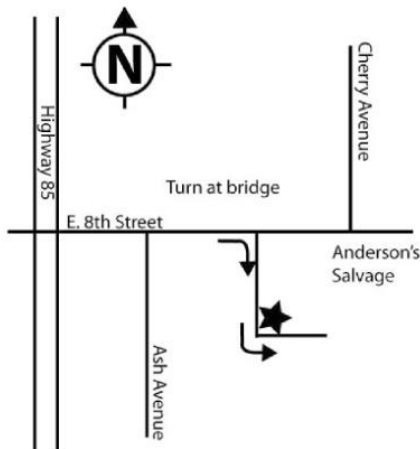
